CIPS CODE OF ETHICS AND PROFESSIONAL CONDUCT

As demand for professional IT services continues to grow around the world, IT practitioners need to gain the confidence and respect of the public. Therefore, IT professionals must establish and maintain a reputation for both integrity and competence.

The CIPS Code of Ethics and Professional Conduct was developed to establish ethical and enforceable standards. The Code shows that CIPS has taken steps to ensure professionalism and integrity to protect the public interest.

Ethical Principles

The following five ethical principles are derived from the *CIPS Code of Ethics and Professional Code of Conduct*. All CIPS members are committed to these principles and perform their work with due regard for public health, safety and the environment.

- 1. Protecting the Public Interest and Maintaining Integrity**
CIPS members protect the public interest and discharge with integrity all duties and services owed to the public, Information Technology (IT) professionals, clients or employers.
- 2. Demonstrating Competence and Quality of Service**
CIPS members owe their client or employer a duty to be competent to perform any IT service undertaken on such a party's behalf. CIPS members serve their client or employer in a conscientious, diligent and efficient manner by providing a high quality of service and by not undertaking a matter without honestly feeling competent to handle it.
- 3. Maintaining Confidential Information and Privacy**
CIPS members hold in strict confidence all information concerning the business and affairs of the client or employer without exception.
- 4. Avoiding Conflict of Interest**
CIPS members do not place personal or professional interests, or those of colleagues, above interests of the public and/or client or employer, and avoid situations where there is a significant risk that the interests of the member may conflict with the public and/or client or employer.
- 5. Upholding Responsibility to the IT Profession**
CIPS members assist in maintaining the integrity of CIPS and the IT profession. They support and advance the interests of CIPS and the IT profession, and respect the rights and professional aspirations of their colleagues.

PRESIDENT'S REPORT

2017-18 marked a very successful year for CIPS (Canadian Information Processing Society) SK. Beginning with a productive Board planning retreat in October that identified our goals and top focus areas and ending with a year that saw record membership and financial growth for our organization.

Year in review:

In October 2017, the CIPS SK Board met for the annual planning retreat in Davidson. The Board of Directors identified 3 key areas of focus for the 2017-18 fiscal year:

- Grow CIPS SK membership. (Growth Committee)
- Support the professional development of our members. (Professional Development Committee)
- Increase awareness of CIPS SK and IT Professionalism. (Awareness Committee)

Tactical initiatives were identified and then delivered throughout the year by subcommittees of the CIPS SK Board of Directors. Key successes by committee included:

Growth Committee

- Membership numbers increased over 300% during 2017-18! At the beginning of July 2017 CIPS SK was made up of 215 members. By July 2018 that number had grown to an amazing 714 members. Key areas of growth have been international and student members.
- CIPS SK has worked in partnership with the Saskatchewan Immigration Nominee Program to validate the credentials of foreign professionals as a step towards immigrating to Saskatchewan. This increase in membership validates the importance of a professional IT designation and the international recognition of CIPS.
- Through the new CIPS Youth Committee, CIPS SK has increased focus on CIPS accredited post-secondary IT programs to introduce the value of CIPS in assisting students with the transition into the IT workforce.

Professional Development Committee

- The Professional Development Committee oversaw the successful delivery of the CIPS SK Mentorship program, regular luncheon events, and the CIPS Professional Development Conference.
- In its first full year, the Mentorship Program has proven very successful based on feedback from both Mentors and Mentees. As a Mentor myself, I found the opportunity to share and to learn from others to be an amazing experience that certainly contributed to my personal growth this year.
- This year's professional development conference titled "Digital Transformation" brought close to 100 IT professionals and experts together to discuss the latest topics within the IT industry.

Awareness Committee

- The Awareness committee focused on activities to increase awareness of CIPS and the professional IT designation to employers, IT practitioners, and post-secondary programs. The committee was instrumental in connecting CIPS SK to students and employers around the province and securing sponsorship revenue.

CIPS National update...

2018 marks the 60th anniversary of CIPS as a National organization! Founded in 1958, as a non-profit organization, CIPS represents thousands of IT professionals on important issues affecting the IT industry and profession. CIPS is a dynamic organization focused on IT excellence through its work on public policy, setting standards within the profession and providing IT support to its community. A couple of CIPS national programs include:

- Certification of IT professionals (Information Systems Professional (I.S.P.) and Information Technology Certified Professional (ITCP) designations); and
- Accreditation of computer science, software engineering, and MIS programs in Canadian colleges and universities.

CIPS also offers other benefits and services to its members ranging from a Code of Ethics and Standards of Conduct to educational conferences and networking opportunities.

Moving forward...

Off the heels of an exceptional year, the plan for 2018-19 will see CIPS SK work to maintain membership numbers by continuing to provide value to our members, to continue to promote and govern IT professionalism, and to maintain the financial health of our organization.

TREASURER'S REPORT

Interim Treasurer

I am excited to present the financial statements for the period of July 1, 2017 to June 30, 2018. This fiscal year we had our financial statements reviewed and prepared by Marvin Bandura with assistance from our bookkeeper, Goldene Mills.

CIPS Saskatchewan has posted a gain for the year of \$26,666

Some reasons for the overall gain include:

1. 140% increase in net membership revenue related to new members including a large increase of international memberships due to CIPS certification requirements for Saskatchewan immigration applications.
2. 340% increase in net conference revenue due to reduced annual conference expenses
3. 11% decrease in general overall expenses which includes reduced office expenses, mailing & printing costs, and other general annual expenses.

CIPS Saskatchewan continues to maintain a healthy balance with \$110,114 in current assets.

Our provincial chapter has made significant strides for CIPS by leveraging alternative membership sources such as the international and immigration communities. This unique opportunity also includes new challenges to maintain and balance membership services for all our members local and abroad. Investments into new programs and remote delivery mechanisms will be needed to ensure we maintain our new international memberships.

Our investments in student awareness and engagement is anticipated to begin increasing the membership numbers as the CIPS Saskatchewan students join the workforce. Lower luncheon event attendances are consistent with the other CIPS chapters as CIPS continues to face competition pressure for IT departments professional development dollars. We have responded to this trend by reducing the number of luncheon events and investing in a larger annual conference which has proven to be beneficial for members and the financial health of the organization.

I would like to thank our Board of Directors, Maria Galati, Executive Director and Goldene Mills our bookkeeper for their assistance this past year. I would also like to thank Past Treasurer, Fred Buschau, who had to step down from the board part way through the year due to work and family commitments. Everyone's dedication has been instrumental in ensuring our financial requirements have been met.

We have a great board and an opportunity to refresh an organization with fantastic history. Continuing to invest in marketing and refreshed programs will help position CIPS within the competitive landscape of Information Technology professional development. I encourage everyone to join the challenge - volunteer and provide input to help shape your professional association!

COMMITTEE REPORTS

MEMBERSHIP COMMITTEE

This past year has yielded an amazing 300% increase in membership. The year began on July 1, 2017 with 215 members and ended in June 30, 2018 with 714 members.

The large increase in membership is due to the influx of applications from immigration. The largest increase occurred in the non-certified category which is now nine times larger than the beginning of the year. Our certified membership almost doubled. The candidate and student

categories each had a healthy increase. As of June 30, 2018 Saskatchewan has the largest provincial membership in Canada.

The CIPS Professional Development Committee has the following three areas of focus:

THE MENTORSHIP PROGRAM

Mentorship Sub -Committee Members

2017/2018 marked the second year of the Saskatchewan CIPS Mentorship Program, which pairs interested mentees and mentors. Each session of the program runs from late fall into the spring, and is intended and designed to facilitate the transfer of knowledge between program participants. The “call” for participation occurs in early fall, followed by the matching of program participants and an Introduction to Mentorship session (held in both Saskatoon and Regina). The program was piloted in 2016-2017 with 6 mentees and 7 mentors, and in 2017-2018 we had 16 mentees and 12 mentors.

Each session of the Mentorship Program starts with a meet and greet and mentorship training event, held in both Regina and Saskatoon, bringing together the mentee and mentor applicants from that geographic area and introducing them to both their assigned partner(s) and to how to be an effective mentee and an effective mentor. The program wraps with an online survey of participants, and survey results have been very encouraging (for 2017-2018 50% of respondents rated the program as “excellent,” followed by 17% rating it as “very good,” and 33% rating it as “good”)

The Mentorship Program is an on-going learning experience for both the participants and CIPS, and CIPS looks forward to continuing to offer and support a program designed to facilitate knowledge transfer in our rapidly changing industry.

THE ANNUAL PROFESSIONAL DEVELOPMENT CONFERENCE

2017 marked the return of the Saskatchewan CIPS Professional Development Conference, and 2018’s professional development conference, Business Transformation, which was held in May had stronger attendance than 2017 (an always encouraging sign). The 2018 conference built on the 2017 conference’s focus on security, and 2018 saw a change in venue as well, to better accommodate increased attendance and for easier travel logistics for attendees from Saskatoon.

The Board of CIPS Saskatchewan strongly believes that offering high-quality pertinent professional development within Saskatchewan is fundamental to serving our membership, and the planning process for the 2019 conference will be starting soon. The growth committee was formed to increase the number of CIPS members. This past year we have successfully increased CIPS membership by 300%. This was accomplished through 3 strategic targets; youth, international and general membership.

To promote membership among youth, we created a CIPS Youth committee at the Moose Jaw Saskatchewan Polytechnic campus. The purpose of the committee is to promote CIPS to the student body and to be a link to the CIPS Board to provide influence and experience volunteerism. We also tried to target student membership in other post-secondary institutions. We delivered a presentation at Saskatchewan Polytechnic in Saskatoon and made contacts to follow up with at the University of Saskatchewan and the University of Regina.

The international membership experienced significant growth this year due to the new legislation that made immigration to Saskatchewan easier for a person holding a CIPS ISP designation. Due to the increase of international membership we wanted to provide value and engagement to those living outside of Canada and unable to participate in our traditional luncheons and our annual conference. We accomplished this by hosting two video conference calls. The first provided an overview of CIPS and discussed the mentorship program. The second delivered a walkthrough of applying for jobs and writing a résumé.

General membership was promoted at the CIPS SK conference. To recruit new members, non-member who attended the conference could sign up for a membership and receive a \$50 discount.

3.2. Treasurer's Report, Trevor McDonald 2016-17 Treasurer Report

I, Trevor McDonald, present the financial statements for the period of July 1, 2016 to June 30, 2017. This fiscal year we had our financial statements prepared by Kenneth B. Gienow, CPA with assistance from our bookkeeper, Goldene Mills.

CIPS Saskatchewan has posted a loss for the year of \$3,023.31.
Financial highlights:

- 7.3% (\$3,770.00) year over year decline in membership fee revenues (15.3% decline over the past 2 fiscal years)
- Total event profit of \$952.25 (loss of \$1,953.14 from events in 2015-16)
- CIPS SK Cyber Security Conference generated \$6,319.70 in revenue
- The CIPS Executive Committee has a plan intended to achieve a balanced budget in the 2017-18 fiscal year. The financial strategy includes the following guiding principles and focus areas:
 - Host monthly luncheon events using a break-even financial model
 - Host a CIPS SK Conference in the spring of 2018
 - Continue with student engagement efforts through the CIPS Youth Committee
 - Continue working with Immigration Saskatchewan to recruit new members

Despite the loss, CIPS Saskatchewan is managing current assets of \$89,098.45, membership numbers are on the rise, and there is a plan in place to achieve a balanced budget in the 2017-18 fiscal year.

I would like to thank Maria Galati our Executive Director and Goldene Mills our bookkeeper for all of their assistance this past year. Their dedication has been instrumental in ensuring our financial requirements have been met.
